Row Crops:

Apply 8 lbs. per 100' x 2', thoroughly incorporating 12" in depth

Field Crops, Orchards and Tree farms:

Apply 600 lbs. per acre twice annually

New Turf Grass, Seeding and/or Landscape Planting:

Thoroughly incorporate 600 lbs. per acre 2-4" deep
